The Board of Directors of Pokarna Limited met on Saturday, the 30th day of July, 2005 and approved the unaudited financial results for 1st quarter of the financial year 2005-2006.

The performance highlights of Pokarna Limited for the 1st quarter of the financial year 2005-2006 are:

- ❖ **Total Turnover** for the quarter under review stood at **Rs.3609 Lacs** recording a growth of **17.25 %** over the same quarter of the previous year ended (31.03.2005), which stood at **Rs.3078 Lacs**.
- ❖ **Profit after tax (PAT)** stood at **Rs. 367.07 Lacs** recording a growth of **6.30%** over the same quarter of the previous year ended (31.03.2005), which was at **Rs.345.30 Lacs**.
